



ORGANIZATION OF CHILD PROTECTION IN DOMESTIC VIOLENCE

Summary: *Although public organizations and non-governmental organizations dealing with domestic violence issues demand the adoption of an act against this type of violence, they are still waiting for a law that has not yet been adopted. Of course, each of us knows that this area should be regulated by a specific law. It should be taken into account that laws and decisions that do not meet the requirements of the present day will lose their relevance. In this context, it would be fair to say that the draft law on the prevention of domestic violence does not provide for special measures and restrictions in order to provide necessary protection and safety to people subjected to violence.*

It is certainly the moral duty of each of us to provide assistance to all victims of domestic violence, including minors and other victims of domestic violence in providing them with jobs and acquiring new professions. Here I would also like to note that we should closely assist people experiencing domestic violence in preparing relevant documents for social protection or in receiving social benefits. If necessary, We should also assist victims in providing temporary shelter.

In order to implement effective preventive measures regarding domestic violence, it is necessary to take measures to restore a normal lifestyle to the families of victims who have been subjected to domestic violence, and to closely assist the victims mentioned above based on the Laws and Acts of the Republic of Azerbaijan.

It would be appropriate to organize mutual aid groups for victims, ensure the implementation of other measures related to the social protection of the victims, conduct surveys and learn the public opinion based on relevant laws. If necessary, It would also be more appropriate to organize meetings with minor victims.

When you cannot defend minors or minor victims of domestic violence, you try to find justification elsewhere. That is why we say that the victim is the one to blame and we even accuse him. After 2014, there has been more work on the mechanisms of protection of victims, which we want to talk about. They take examples from developed countries, but for now all of them are illustrative nature.

What do victims of domestic violence know about their rights? Do they know that both the police and the court are obliged to protect them. Do they know that beating and humiliating them is illegal? Do they know that family members do not have the right to beat and humiliate them, to control their fate and actions?

Introduction.

If we pay attention to domestic violence, we will see that it does not have a positive effect on young children. That is, as children understand the spiritual side of their actions, their interaction with adults and friends becomes more complicated. Their communication and behavior begin to be determined by moral criteria. In this regard, not being subjected to social and domestic violence during the period of formation of imagination and thinking in young children will make him a spiritually rich and cultured person and personality. That is, this is the period of formation and enrichment



of the child's personality, as well as the beginning of its improvement. Therefore, it is necessary to protect these children and properly guide them. Here you can put an end to violence that needs to be eradicated by referring to the Convention on the International Protection of Children, and at the same time you can rely on the laws of the Republic of Azerbaijan on the protection of children. Taking into account the relevance of these principles and processes, we can say that analyzing the current situation, we can see both children and adults exposed to domestic violence (1).

Witnesses of violence.

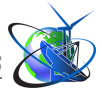
Although violence is not directly targeted at the child, we sometimes close our eyes to problems or facts that are harmful to the child and his development. The cause and consequences of this are revealed later and spread to undefined issues. In front of everyone, we do not prevent the problems that arise by ignoring the existence of the child who has been subjected to violence. It would be appropriate if we were not indifferent to the danger of their consciousness, thinking, existence and life and even paid attention to them (2).

As soon as most children who have witnessed domestic violence in society change their environment, they recall the events they observed from that time and also make the bell form in that shape. Although we have come across different ideas on how to influence them, we have witnessed different results.

Here I can also note that children are almost always aware of domestic violence and in such cases are also witnesses or victims themselves of this violence.

Regardless of Whether they reach adulthood or not, they live in these events, witnessing different events depending on their age and environment. I can also note that adults usually underestimate the degree of violence their children endure. Parents' descriptions of their children's experiences cannot be considered reliable in assessing the impact of violence on children.

It can be said that all children with learning difficulties were victims of depression at some point. They were resisted and continued to be pressured. After some time, these events began to unfold. We are witnessing the emergence of challenges in preventing such negative situations.



Social work in the field of domestic violence.

There is much to be said about depressed and anxious children. Observing their role in society, we become witnesses to their depression.

The safety of the environment in which each child lives must be ensured in the time we live and in the world we face. We need to solve the problems they face in time so that they do not linger and do not face problems in the future. In this case, the other parties must be informed to take timely measures to eliminate their dangerous moments for the protection of children together with social services and business institutions designed for emergency situations (3).

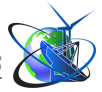
Any number of ideas about the stage of children's development can be touched upon and analyzed. From their lifestyle to their education and moral values.

We can talk about each of the points, from the psychological state of each child, teenager and young person to their activities in life and the reality of the educational process.

When trying to draw a conclusion about the child's emotional attitude towards the criminal and the victim, first of all, we should prioritize their psychological state. Here, when we compare the child and the parent or the child and the environment, we see that both disappointment and attitude develop in children in different aspects. Here we can also see that children become victims of a negative or positive risky character with their own crude fantasy.(4)

At the same time, the basis for the development of cruelty in children in its highest form, rather than mercy, is one of the factors that accelerates the emergence of violent events in front of children. If we look at the inevitable from another point of view, we can say that since children live in fantasy, not in reality, violence shapes their thoughts and opinions in a negative direction.

It is also worth mentioning here that long-term exposure to violence can also manifest itself in the children's future lifestyle: it can also lead to illiteracy, crime, and the development of new violent events when interacting with like-minded people. Although the tendency of children to keep up with the times is based on the upbringing of their parents, it would be appropriate to say that in some cases, children themselves



make decisions that lead to violence.

It can also be noted that sociological types who are subjected to violence are closed and avoid social communication, which ultimately leads to an increased tendency to suicide and aggressive behavior. On the other hand, the fact that these parents do not maintain relationships with their relatives and do not establish social communication leads to a violation of the behavioral order. One of the main factors in eliminating these symptoms is that the use of the motto "who reads a lot, knows more, and who walks a lot, knows more" can help to find a way out of the situation by establishing and conducting a dialogue, a certain inclination to communication. This means moving forward in a positive direction, helping the dream to become reality (5).

In order to ensure the organization of protection of children from domestic violence, we must not be indifferent to the observed violence, we must always look for a way out of the crisis and ask state structures to help eliminate this anxiety. This may lead to protect one or more children becoming victims of bullying and getting rid of behavioral disorders and aggressive behavior.

When we look at the diagnostic picture, we see that violent trauma on children differs dramatically from that on adults. In other words, the impact of this violence on the child's brain leads to illnesses and early death. This means the end of a new generation or its absence at all. Older people from this category are doomed to incurable diseases and white death. From a sociological point of view, this is one of the factors causing society to lag behind in moral and psychological development. Here, against the background of inevitable events, we can also see that the events taking place in the world of this child have a negative impact on the formation of a personality that meets the demands of the day. At the same time, they are children and representatives of the younger generation who can become either the perpetrators or the stopper of criminal events (6).

Gender aspect of domestic violence.

When we look at the psychology of children who have been subjected to violence and their peers, we see that they are different from each other. That is, they are not like others in their different behavior in society. It is necessary to closely know the



psychological characteristics of this person, to correctly take him into account in the process of activity and communication, to see him on the same level with other professionals and educated people and to give them the right direction. Penetration into the spiritual world of this type of people, the right direction of development of their abilities requires not only great social responsibility, but also very serious psychological understanding from intelligent people, that is, people with a normal way of thinking. The only way to get children and adults who have become victims of domestic violence out of this situation is to provide them with psychological support. When we talk about the initial natural conditions of development of those persons or personalities, first of all, it is necessary to take into account the general factors of the environment. Depending on the climate conditions and the place of residence of a person, there are unique aspects of his lifestyle and living conditions that make him stay away from society and withdraw into himself. Considering all this, we can ask ourselves this question. How can we prevent such situations and raise a morally rich person instead of violence? If you think about it consciously, from the day of the child's birth, the status or position of the parents, their economic, political and legal status, profession, education, and so on, changes. Abrupt changes in the material and spiritual life of the family directly affect the conditions for the formation of the personality. This has a negative impact on the growth of the newly traumatized person. When the status of the family is more or less stable, this leads to the strengthening of the individual qualities of the personality and, at the same time, possibly to the formation of a new thinker or scientist. Even psychology, which regulates the solution of such a social problem arising in the household, cannot have a sufficient influence on the prevention of this problem. Because these events, whether social violence, or people who cannot form in society, are tired from time to time and have used this violence themselves. Although all these opinions are one-sided, a way out can be found based on methodological principles. In addition to the sociological factor, they are also based on the biological factor. Thus, if one of the parents sometimes has a mental ~~defect or a~~ physical defect, this negatively affects the formation of a healthy body and a healthy spiritual personality for society (7; 8).



The emotional behavior of children who have been subjected to violence also deserves attention. That is, the reason for their lack of mood is not entirely clear. Even they sometimes cannot clearly understand why they are in a particular mood. Even a minor incident can make these people lose their temper and provoke a loss of control over their feelings. That is, mood affects a person's imagination and thoughts, their content and direction, and their attitude to the world around them. In short, when a person is in a joyful and cheerful mood, everything around them has a good effect on them. Therefore, a person should not be a slave to their mood, but should always be able to fight negative moods. Moreover, a person's mood can be contagious. In other words, people around them can subject a person to social violence or make them suffer (9).

Result

In principle, in order to convince them of these facts, they tried to mobilize new types of ideas and considerations in their brain factor by realistically explaining various practical experiences to them. To achieve this goal, of course, the duties of psychologists or workers in this field who have to determine genetic codes are also complicated and sometimes remain hanging by a thread. Here the question arises. How to determine the genetic code? Of course, first of all, in addition to the family in which the child was born, it is necessary to analyze the environment in which the child was formed and grew up, and, without making any possible conclusions in advance, communicate with this child or person in certain areas, listen to and analyze their opinion and, finally, make a final decision on what psychological help is needed to determine that help will be provided. If this is not prevented, then, of course, this person will increase the number of those like him, on the wrong path, or, in addition to the fact that he will initiate some crime, this will cause a growth in new criminals.

When the first case was opened against children and minors who were victims of domestic violence, many tried to make them think about this issue and guarantee them their invulnerability. They were assured that no one would come to the shelter.

I believe that in the regions it is necessary to organize discussions with young people who have not reached adulthood. The goal should be to cultivate a sense of



mutual understanding in healthy relationships and to protect the national moral values of the Azerbaijani society, as well as to make a decision on the negative consequences emanating from the values of people who have become victims of violence.

Indeed, there is a mechanism for granting the status of a victim of domestic violence. This mechanism allows children who have been subjected to domestic violence and who have not reached the age of maturity to use state services, such as placement in shelters, psychological rehabilitation or legal assistance.

The greater amount of violence in the article, the study of its directions, the identification of important and significant problems in this work indicate the relevance of the topic.

The solution to the economic and financial crisis in the world, domestic violence, the study of structural problems of victims of children, minors and all who have become victims of domestic violence, and the presentation of the problem in a scientific and theoretical context as a fundamental work is an urgent task.
